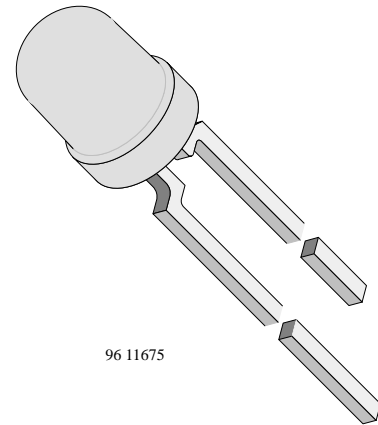

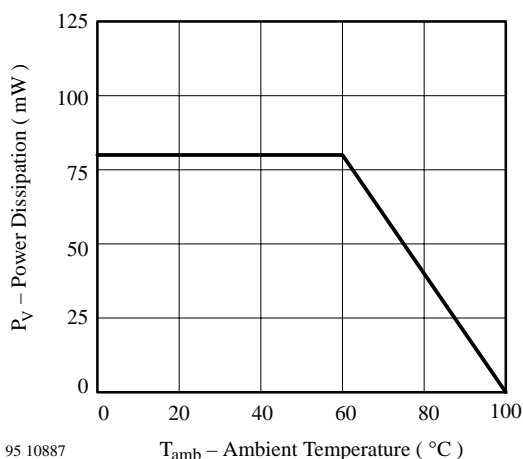


Figure 1 Power Dissipation vs. Ambient Temperature

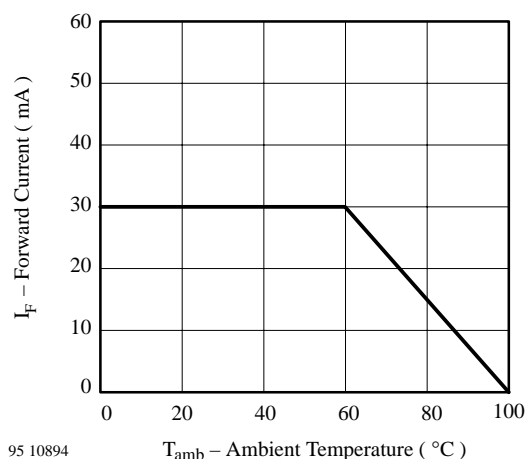
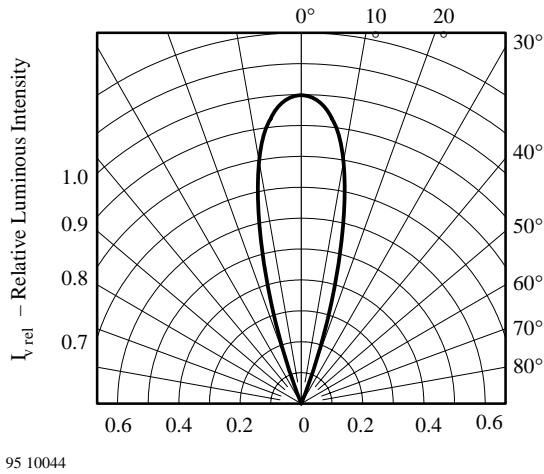
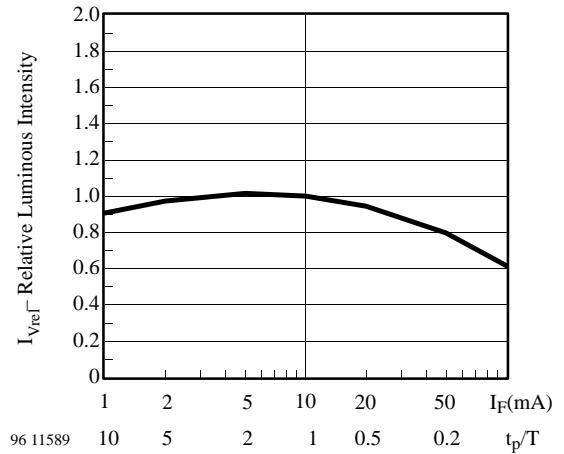


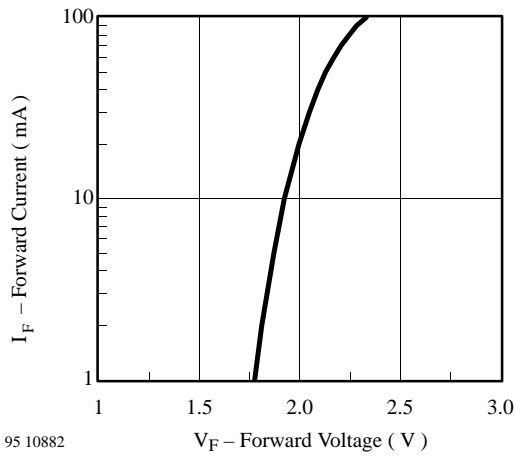
Figure 2 Forward Current vs. Ambient Temperature



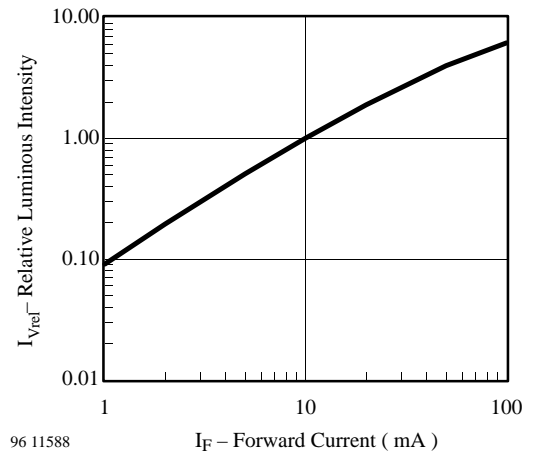

Figure 3 Rel. Luminous Intensity vs. Angular Displacement



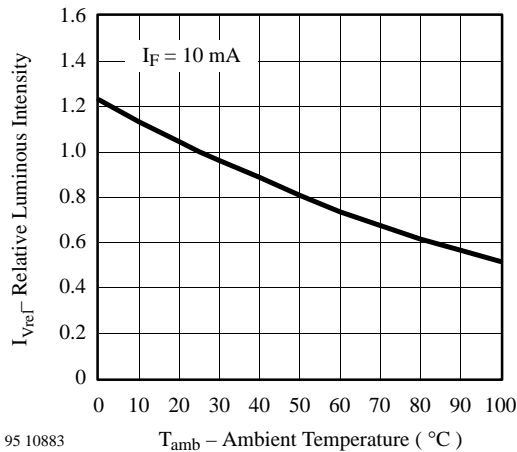

Figure 6 Rel. Lumin. Intensity vs. Forw. Current/Duty Cycle



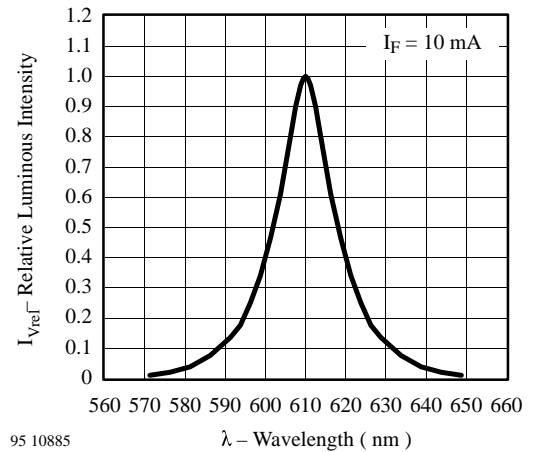

Figure 7 Relative Luminous Intensity vs. Forward Current

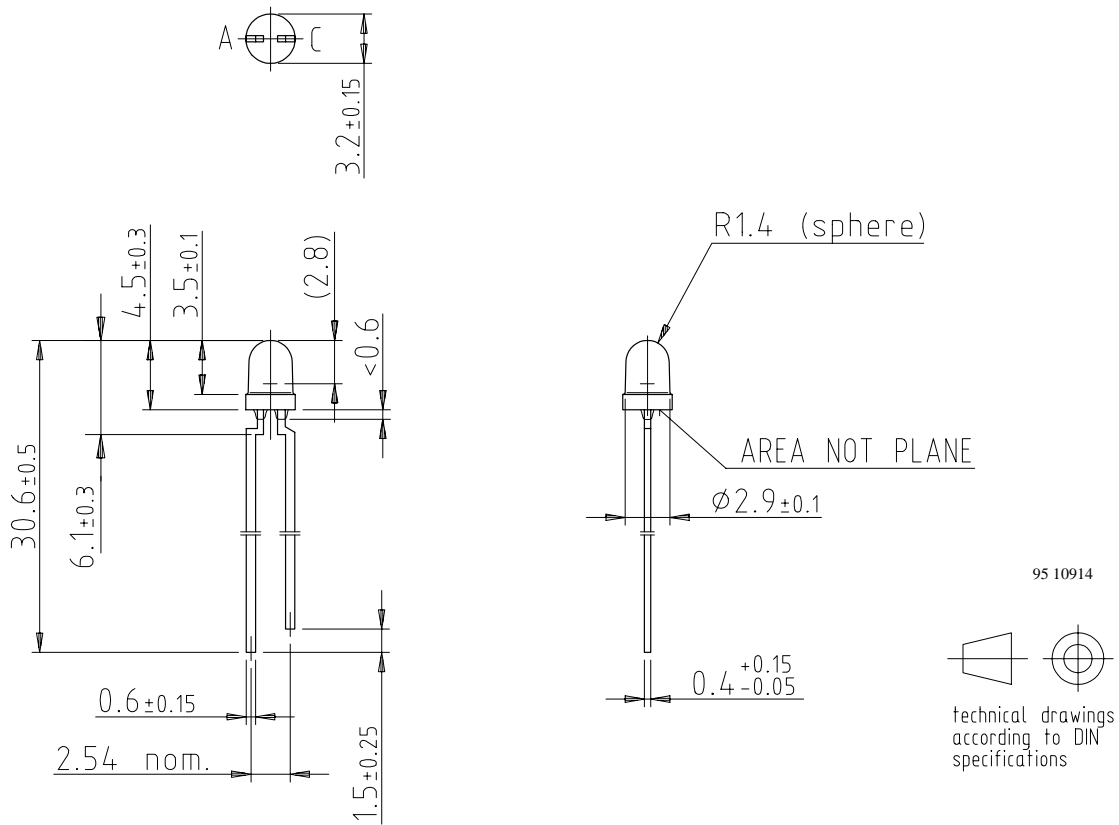
