




Figure 1 Power Dissipation vs. Ambient Temperature




Figure 2 Forward Current vs. Ambient Temperature




Figure 3 Forward Current vs. Pulse Length




Figure 4 Rel. Luminous Intensity vs.
Angular Displacement




Figure 5 Forward Current vs. Forward Voltage




Figure 6 Rel. Luminous Intensity vs. Ambient Temperature




Figure 7 Rel. Lumin. Intensity vs. Forw. Current/Duty Cycle




Figure 8 Relative Luminous Intensity vs. Forward Current






Figure 9 Relative Luminous Intensity vs. Wavelength

Ozone Depleting Substances Policy Statement

It is the policy of Vishay Semiconductor GmbH to

- 1. Meet all present and future national and international statutory requirements.

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

Vishay Semiconductor GmbH can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
