

Optocoupler with Phototriac Output

Description

The K3010P(G) series consists of a phototransistor optically coupled to a gallium arsenide infrared-emitting diode in a 6-lead plastic dual inline package. The elements are mounted on one leadframe using a **coplanar technique**, providing a fixed distance between input and output for highest safety requirements.

Applications

Circuits for safe protective separation against electrical shock according to safety class II (reinforced isolation):

- For appl. class I IV at mains voltage ≤ 300 V
- For appl. class I III at mains voltage ≤ 600 V according to VDE 0884, table 2, suitable for:

Monitors, air conditioners, line switches, solid state relays, microwaves.





Figure 1. Test circuit for dv/dt_{cr} and dv/dt_{crp}

 dv/dt_{cr} Highest value of the "rate of rise of off-state voltage" which does not cause any switching from the off-state to the on-state

dv/dt_{crq} Highest value of the "rate of rise of communicating voltage" which does not switch on the device again, after the voltage has decreased to zero and the trigger current is switched from I_{FT} to zero




Figure 3. Motor control circuit








Figure 5. Test pulse diagram for sample test according to DIN VDE 0884




Figure 6. Total Power Dissipation vs.
Ambient Temperature




Figure 7. Forward Current vs. Forward Voltage




Figure 8. Relative Threshold Forward Current vs.
Ambient Temperature




Figure 9. Relative On - State vs. Ambient Temperature




Figure 10. Off - State Current vs. Ambient Temperature




Figure 11. On - State Current vs. Ambient Temperature









Figure 12. Marking example


Dimensions of K301.PG in mm
