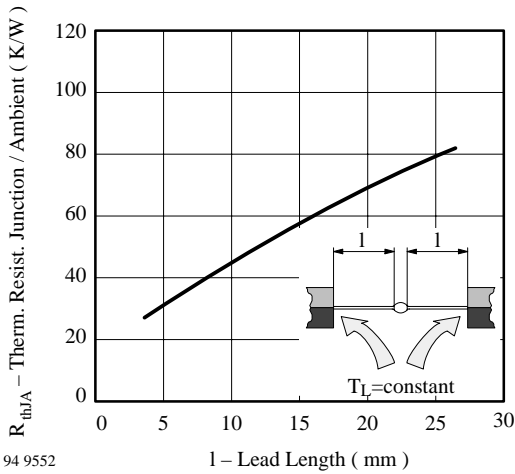

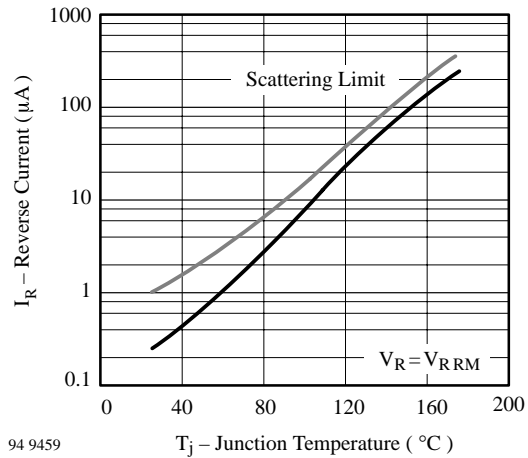

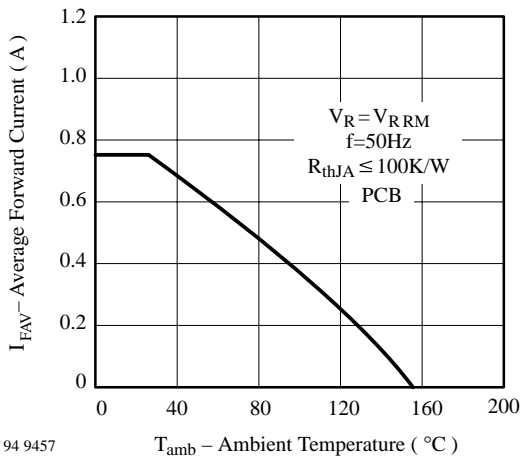

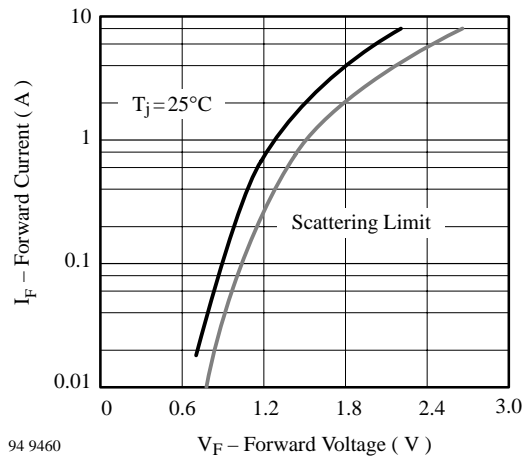
94 9552  $R_{thJA}$  – Therm. Resist. Junction / Ambient (K/W)

 Figure 1. Max. Thermal Resistance vs. Lead Length



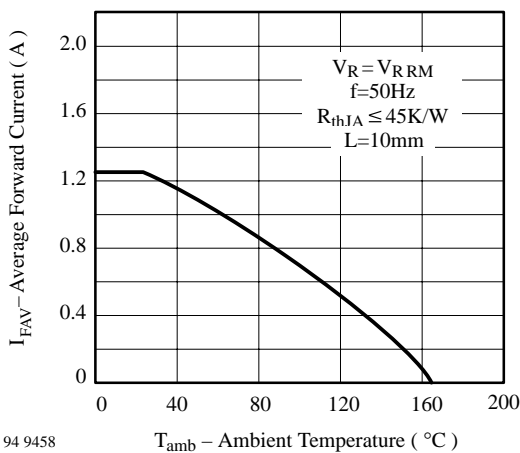
94 9459  $I_R$  – Reverse Current ( $\mu\text{A}$ )

 Figure 4. Reverse Current vs. Junction Temperature



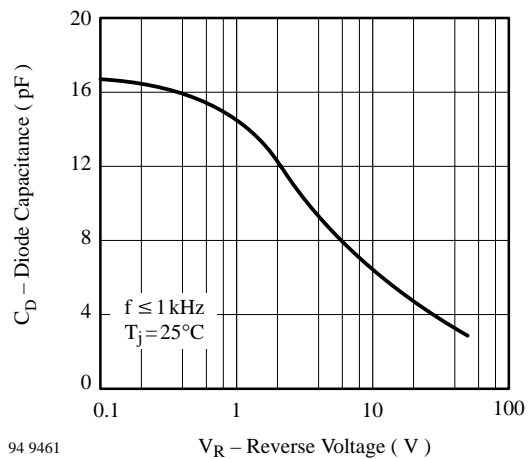

 Figure 5. Forward Current vs. Forward Voltage

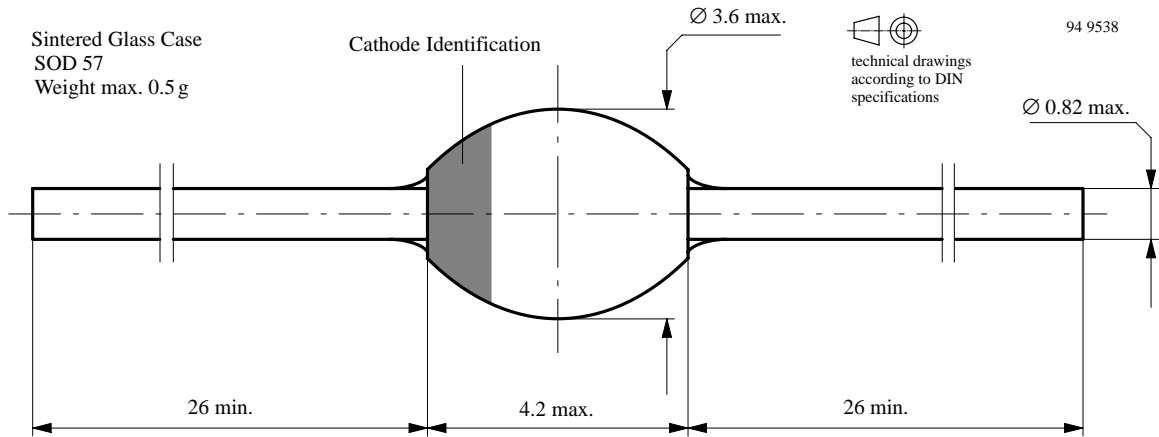


94 9458  $I_{FAV}$  – Average Forward Current (A)

3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
