








Figure 2. Max. Average Forward Current vs. Ambient Temperature

Figure 3. Forward Current vs. Forward Voltage





Figure 4. Reverse Recovery Time for I<sub>RM</sub> vs. Forward Current Rate of Change




Figure 6. Reverse Recovery Time vs. Forward Current Rate of Change




Figure 7. Reverse Recovery Charge vs. Forward Current Rate of Change



### **Ozone Depleting Substances Policy Statement**

It is the policy of Vishay Semiconductor GmbH to

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

Vishay Semiconductor GmbH can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
