## FUNCTIONAL DIAGRAM


## DESCRIPTION

The Xicor X9316 is a solid state "micropower" nonvolatile potentiometer and is ideal for digitally controlled resistance trimming in battery-powered systems.

The X9316 is a resistor array composed of 31 resistive elements. Between each element and at either end are tap points accessible to the wiper element. The position of the wiper element is controlled by the  $\overline{CS}$ , U/ $\overline{D}$ , and  $\overline{INC}$  inputs. The position of the wiper can be stored in nonvolatile memory and then be recalled upon a subsequent power-up operation.

The resolution of the X9316 is equal to the maximum resistance value divided by 31. As an example, for the X9316W ( $10K\Omega$ ) each tap point represents  $323\Omega$ .

All Xicor nonvolatile memories are designed and tested for applications requiring extended endurance and data retention.

## **PIN DESCRIPTIONS**

## $V_H$ and $V_L$

The high (V<sub>H</sub>) and low (V<sub>L</sub>) terminals of the X9316 are equivalent to the fixed terminals of a mechanical potentiometer. The minimum voltage is V<sub>-</sub> and the maximum is V<sub>+</sub>. It should be noted that the terminology of V<sub>L</sub> and V<sub>H</sub> references the relative position of the terminal in relation to wiper movement direction selected by the U/D input and not the voltage potential on the terminal.

## v<sub>w</sub>

 $V_W$  is the wiper terminal, equivalent to the movable terminal of a mechanical potentiometer. The position of the wiper within the array is determined by the control inputs. The wiper terminal series resistance is typically 100 $\Omega$ .

## Up/Down (U/D)

The  $U/\overline{D}$  input controls the direction of the wiper movement and whether the counter is incremented or decremented.

## Increment (INC)

The  $\overline{\text{INC}}$  input is negative-edge triggered. Toggling  $\overline{\text{INC}}$  will move the wiper and either increment or decrement the counter in the direction indicated by the logic level on the U/D input.


## Chip Select (CS)

The device is selected when the  $\overline{CS}$  input is LOW. The current counter value is stored in nonvolatile memory when  $\overline{CS}$  is returned HIGH while the  $\overline{INC}$  input is also HIGH. After the store operation is complete, the X9316 will be placed in the low power standby mode until the device is selected once again.

## V<sub>+</sub>, V<sub>-</sub> (Analog positive/negative power supply)

The  $V_{\rm +}$  and  $V_{\rm -}$  pins supply an external voltage to the wiper position decoder.

## **DEVICE OPERATION**

There are three sections of the X9316: the input control, counter and decode section; the nonvolatile memory; and the resistor array. The input control section operates just like an up/down counter. The output of this counter is decoded to turn on a single electronic switch connecting a point on the resistor array to the wiper output. Under the proper conditions the contents of the counter can be stored in nonvolatile memory and retained for future use. The resistor array is comprised of 31 individual resistors connected in series. At either end of the array and between each resistor is an electronic switch that transfers the potential at that point to the wiper.

The  $\overline{INC}$ , U/ $\overline{D}$  and  $\overline{CS}$  inputs control the movement of the wiper along the resistor array. With  $\overline{CS}$  set LOW the X9316 is selected and enabled to respond to the U/ $\overline{D}$  and  $\overline{INC}$  inputs. HIGH to LOW transitions on  $\overline{INC}$  will increment or decrement (depending on the state of the U/ $\overline{D}$  input) a seven bit counter. The output of this counter is decoded to select one of thirty two wiper positions along the resistive array.

The wiper, when at either fixed terminal, acts like its mechanical equivalent and does not move beyond the last position. That is, the counter does not wrap around when clocked to either extreme.

The value of the counter is stored in nonvolatile memory whenever  $\overline{CS}$  transistions HIGH while the  $\overline{INC}$  input is also HIGH.

When the X9316 is powered-down, the last counter position stored will be maintained in the nonvolatile memory. When power is restored, the contents of the memory are recalled and the counter is reset to the value last stored.

## **Operation Notes**

The system may select the X9316, move the wiper and deselect the device without having to store the latest wiper position in nonvolatile memory. The wiper movement is performed as described above; once the new position is reached, the system would the keep  $\overline{INC}$  LOW while taking  $\overline{CS}$  HIGH. The new wiper position would be maintained until changed by the system or until a power-up/down cycle recalled the previously stored data.

This would allow the system to always power-up to a preset value stored in nonvolatile memory; then during system operation minor adjustments could be made. The adjustments might be based on user preference, system parameter changes due to temperature drift, etc...

The state of  $U/\overline{D}$  may be changed while  $\overline{CS}$  remains LOW. This allows the host system to enable the X9316 and then move the wiper up and down until the proper trim is attained.

## T<sub>IW</sub>/R<sub>TOTAL</sub>

The electronic switches on the X9316 operate in a "make before break" mode when the wiper changes tap positions. If the wiper is moved several positions multiple taps are connected to the wiper for  $t_{IW}$  (INC to V<sub>W</sub> change). The R<sub>TOTAL</sub> value for the device can temporarily be reduced by a significant amount if the wiper is moved several positions.











## **TYPICAL NOISE**




## **TYPICAL RTOTAL vs. TEMPERATURE**






## TYPICAL TOTAL RESISTANCE TEMPERATURE COEFFICIENT


## **TYPICAL WIPER RESISTANCE**






## **TYPICAL ABSOLUTE % ERROR PER TAP POSITION**






14-LEAD PLASTIC SMALL OUTLINE GULL WING PACKAGE TYPE S
